Mtg 1 - 12 June 2018, Birmingham

The first meeting of the year and Ian's last as facilitator and a strong education theme.

Crystal Oldman CEO of the QNI started the round with a review of the QNI's on-going work, including:

- Influencing Practice Nurse Education
- Their work on Homelessness'
- The leadership development for Queens nurses
- Introduction to the work that the QNI will be doing with Suzanne Gordon from her book from silence to voice what nurses know and must communicate to the public.

Health Education England presented the ongoing work around District Nurse Education. This followed an enthusiastic session on the District Nurse Specialist Practitioner Qualification moving towards the Apprenticeship Standard led by Steph Lawrence .

Emma Self updated the group on NHSE work relating to the community.

Sue Hill and Sue Rayment feedback from the recent RCN conference and its impact on District Nursing.

Meeting 2 - 11 September 2018, London

My first meeting as facilitator and Rebekah as co chair. The agenda was packed.

Up first was :

Crystal Oldman CEO of the QNI with the update of the QNI's work, which includes dialogue with Health Education England around the DNSPQ. Also from the QNI was Agnes Fanning who's work on Outstanding Models of Care needed the networks views and support, which we were pleased to offer.

Emma Self from NHSE gave an overview of the upcoming NHS long term plan, and Michelle Mello gave a 'different' presentation using the views of a retired district nurse as Personalised Care comes into focus in the Long Term Plan.

Matt Ina Kim, National Clinical Advisor for NHSE gave a very poignant presentation on recognising sepsis .

Meeting 3 - 11 December 2018, Manchester

Winter in Manchester, my home ground. This meeting always attracts a big crowd and this was no different. I was a lone wolf as both co-chairs were unable to attend due to sickness and work commitments.

Emma Self from NHSE kicked off the proceedings with further update on the upcoming Long Term Plan and asked the members for their thoughts and opinions on the plan.

Sue Boran from the QNI attended to give an update on the QNI's work .

As we were in Manchester I had invited colleague, Alicia Waite to discuss the integrated working between the Macmillan nurses and the District Nurses in North Manchester.

Our final speaker was on Field Service Management, Malinko – this is a company who builds and develops scheduling tools and has worked with NHS organisation's across the country, he was joined by the lead nurse from Neighbouring Salford who have developed and worked with Malinko on scheduling. As you can imagine this generated a lot of discussion and interest from the Network.

Meeting 4

The last meeting of this round and we were back to full strength with David and Rebekah's return.

Crystal started off proceeding with an update from the QNI. There are still ongoing discussions with HEE about the SPQ DN although the apprenticeship standard the trailblazer group, led by Steph Lawrence, has been accepted by skills for health.

Emma gave an overview of the recently released Long term plan and discussed what the impact of it maybe on district nursing – particularly around primary care networks, which led to some discussions on the promised extra funding.

Our members from Bradford, Carla Smith and James Cooke presented the work they have done on reducing insulin errors, the work resonated with all the group and the network will continue to support and draw on the work across the country so we can look at some national principles .

Jenny Wood from NHSI gave a presentation about the service delivery model to improve productivity on the back of the Carter report. This again is something that we will continue to support.

Future Plans for 2019-20

The following year for the group is exciting as there remains a great enthusiasm to join and share challenges being faced within District Nursing. Meetings continue to be planned on a quarterly basis, attracting expert speakers who inform the group of current issues.

NPAG Developments

CPD Certification

The NPAG is a member of the CPD Certification Service. The National District Nurses Network has received CPD approval for 2018-19.

CPD Certification is a formal recognition of the contribution that membership of the National District Nurses Network makes to members' continued professional/personal development.

At the end of the annual round of meetings, members will receive certificates of attendance for all meetings attended during the year to evidence the contribution made as part of lifelong learning.

NPAGNetwork

The NPAGNetwork provides the facility for members to ask questions of any individuals, group or groups within the overall NPAG membership. Questions can be sent to the NPAGNetwork Coordinator who disseminates them across the NPAG membership. Responses are collated and returned to the originator and others who declare an interest in the question asked.

NPAG Library

The NPAG Library holds presentations from NPAG best value groups and conferences, together with policy and other documents sent in by members. Access to these items is via the NPAGNetwork Coordinator.

NPAG Website

The NPAG website includes a private members Area for each of the NPAG BVGs. Through these sites, BVG members can access and download meeting agendas, minutes, presentations and survey forms. The areas are password protected.
